LET IT SNOW, LET IT SNOW, LET IT SNOW

Before you know it, snow removal season will be here. It has always been difficult for the HOA to find space for snow storage during even a moderate snowfall. With the development in Block 10, we can no longer use that space to pile snow. As such, Metco and the HOA have to get creative.

The alleyway behind the 2110 Building and the detention pond at the south end of the alley will be the main repository for plowed snow from Blocks 8 and 9. There will be some snow piles at the north end this alleyway between Buildings 2226 and 2250. Unfortunately, the majority of the snow from the Block 8 alleyways will have to be taken by front loader to the aforementioned areas in Block 9 since there is little room there for snow storage. This will be an added cost to our budget for/snow removal.

Due to the limited space for snow storage, it is more important than ever to keep the alleyways clear. Please do not park your car, even for a short period of time, in the alleys. Any vehicle parked in the alley that impedes the snow plows will be towed at the owner's expense.

As in the past, the trigger snow level is 2 inches for both shoveling and plowing. On the days Metco removes snow, they will hand shovel a path from the side walk to the front doors of the townhomes and duplexes.

Snow melt buckets will once again be placed on the north side of Buildings 2270 and 2226 for safety purposes. Any homeowner may request an ice melt bucket delivered to their home for personal use by emailing our property manager, Dan Anderson at <u>danderson@metropropertymgt.com</u>.
