- C. Paul Teven, 2172 B, has concerns about the poor condition of the alleyways in Block 9. This is a large expense, and the board has not chosen to make this a priority. Another concern is concrete spalling which may be worsened by the overuse of ice melt. Dan will discuss this with the landscape company.
- D. Mark Fisher, 22270 D, made a comment about the need for tree maintenance in his courtyard. This will be addressed in 2023. Mark also asked about the difference between special assessment and use of reserves for projects. Dan provided an overview.
