



# Clubhouse & Pool Rules



## VCC Pool | Hot Tub

The community pool and hot tub are open daily during the summer season. Unless otherwise noted, the hours of operation during this period are as follows:

Sunday - Thursday; 8am to 9pm | Friday - Saturday; 8am to 10pm

The pool and hot tub are available for use by residents. An adult VCC resident must be present and accompany all guests while in the pool area. Responsibility for children under the age of 13 rests solely with an adult VCC resident. Please note that there are **no Lifeguards on duty**; residents and guests swim at their own risk.

For detailed guidelines, refer to the VCC HOA Rules and Regulations, Appendix B (included as page 2 with this announcement).

The VCC Pool and pool area are not available for private use and are not included within any Clubhouse reservation. **Pets** of any kind are strictly prohibited in the Clubhouse and pool areas.

## VCC HOA Rules and Regulations, Appendix B

---

There is **NO Lifeguard on duty, swim at your own risk.**

The Villas at Cherry Creek pool is for use by residents only. All guests must be accompanied by an adult resident at all times. To ensure an enjoyable experience for all, residents are asked to limit the number of guests per household.

Pool access is available to all residents who are current on their HOA dues and who agree to follow the established rules. Violations of pool rules or delinquency in dues may result in suspension of pool privileges.

Children under the age of 13 must be supervised by an adult resident while in the pool area. Before allowing a child to use the hot tub, please consult with the child's physician.

Proper swim attire is required for all pool users.

Children in diapers must wear swim-type diapers.

The following **items** are NOT permitted in the pool area:

- Skates - skateboards
- Smoking - of any kind
- Glass items - of any kind. Use can drinks, plastic or acrylic containers/cups.
- Absolutely NO pets

The following **actions** are NOT permitted in the pool area:

- No diving or throwing people into the pool
- No running
- No climbing of the pool area fence or gates
- No unsafe behavior
- No loud music

Do not open the **pool gates** for anyone who does not have a pool access fob. The gates close automatically after entry—**do not prop them open at any time.**

Before leaving the pool area, please lower all umbrellas and ensure the ties are wrapped securely around them.

If you access the clubhouse bathrooms from the pool area level, make sure all French doors to the bathroom area are closed before leaving the pool area.
